STOURS PARISH COUNCIL

Minutes of the Parish Council Meeting held at 7.30pm on Thursday 9th January 2014 in West Stour Village Hall

The Chairman welcomed those present and thanked Cllr Parker for doing the minutes of the last meeting, due to the Clerk's absence.

Reports, Pre-business matters and Public participation

DCC MEMBER'S REPORT - Cllr Cattaway sent his apologies and said there is nothing to report.

NDDC WARD MEMBER'S REPORT.

Cllr Mrs Handford sent her apologies. Her report was read to the meeting. The main points were that the Local Consultation Plan runs until 24th January 2014. NDDC has been awarded a prestigious European award for its community planning work. Mr Stephen Howard will be attending the Overview and Scrutiny meeting on 29th January 2014 if anyone has any questions please let Traci know. Also if there any issues with Dorset Waste Partnership.

Footpath and Tree Liaison Officer's report

Mr Hibbert said that footpaths are waterlogged but useable with care. Footpath issues at Lyde Hill Farm are still not resolved. The diversion for FPs 22 & 24 at Joliffe's Farm, Margaret Marsh has today been confirmed by the Planning Inspectorate. FP 64, Mead Farm proposed diversion is going through. Cllr Gould said that he will be meeting with DEFRA within the next few weeks and he will find out more about farm security and electric fencing. At Todber parish meeting it was said that a footpath around the lake across the bridge is obstructed by an electric fence. Following an amicable meeting with the landowner this has now been sorted with a minor alteration to the route. West Stour held a walk at Whitesheet Mere. There are proposals to hold more walks involving all the villages within the Stours. All welcome. Mr Julian Trim is hoping to build 2 new dwellings at the Lynch, West Stour. Part of the deal should he get planning permission is to improve the green lane at The Lynch. He has met with Mr R Skeats, Highways Technical Officer, Dorset County Council. There will be further consultations, when the planning application is received, with West Stour councillors and parishioners.

Trees – no new reports.

<u>Flood Wardens' report</u> – There has been flooding especially along the A30 East Stour but drivers appear to take care. The water soon recedes.

<u>Transport</u> – Cllr Mrs Newton said that the meeting had been cancelled. Calculations need to be done again for the proposed cuts in bus services. There will be another meeting.

2014/05 MATTERS ARISING

- Cheque no 1544 for £1425.96 payable to Broker Network Insurance is the Parish Council's annual insurance. The payment is the norm for the council (previous year's payment was £1425) as it covers the council and the four wards.
- Gypsy and Travellers at Five Bridges lay-by. They have now vacated the site. Concerns were raised that the site
 will be occupied again. The site cannot be closed off as access is required for Wessex Water and space is required
 for HGVs turning.

2014/11 HIGHWAY MATTERS

 Speed restriction request for Stower Provost School. Cllr Ratcliffe said that the arranged Governors' meeting had been overtaken by other events. Another one will be arranged by the end of term. The road past the school is straight from both ends and vehicular drivers tend to drive too fast along the road. Cllr Ratcliffe requested support from the parish council to have a speed limit by the school. It was resolved that the Stours Parish Council support the request for a speed limit by Stower Provost Community School. Cllr Ratcliffe will let the Governors know of this support.

2014/12 APPLICATION FOR A PUBLIC PATH DIVERSION ORDER - PRE-APPLICATION CONSULTATION

Footpath N71/64 Meads Farm – does the council support the proposed diversion? This has been discussed at previous meetings. The Ramblers Association support the application. It was agreed that The Stours Parish Council support the proposal at the present time but reserve the right to withdraw support later. Proposed by Cllr Mrs Newton, seconded by Cllr Lady Stagg and agreed by all.

2014/13 CODE OF CONDCUCT (LOCALISM ACT)

Principles of The Code and Member Obligations (brief summary of Code of Conduct session). Deferred to the next meeting.

2014/14 EAST STOUR VILLAGE ACTION PLAN

Cllr Little reported on the progress of the action plan. In summary: - The Village History Group has submitted an application for a grant of £7500 to the Heritage Lottery. The playing field has had its trees pruned. Projects are being looked into to improve the facilities, e.g. a circular path around the field, baby swing, replacing the disintegrating commemorative stone, the planting of 4000 bulbs and planting 4000 more later. Dr Austin-Joes will be providing two seats in memory of her late husband. The land by Oswald Barn, A30 will be landscaped.

He said that he is now Chairman of East Stour Village Hall Committee and that Oliver Salisbury has stepped down. There will be a meeting in a few weeks' time to discuss hall improvements. Ideas welcomed. Cllr Little was thanked for his report.

2014/15 PURCHASE OF PICNIC TABLE/BENCH AT EAST STOUR PLAYING FIELD

2014/16 GROUNDS MAINTENANCE FOR EAST STOUR AND STOUR PROVOST PLAYING FIELDS

It was agreed at their respective parish meetings to continue to use Philip Buttress to maintain the playing fields. East Stour price per cut £70 and Stour Provost £50. The council is pleased with Philip's work and complimentary comments have been made by the members of the public.
